Subject: Revised Interest on late payment of Deviation Settlement charges for 1st, 2nd, 3rd and 4th quarter of FY 2019-20.

The interest on late payment of Deviation Settlement charges for 1st, 2nd, 3rd and 4th quarters of FY 2019-20 had been calculated and issued as per provisions in CERC (Deviation Settlement Mechanism and related matters) regulations 2014 vide NRPC letter of even no. dated 4th November, 2020. There was a discrepancy in Net Schedule Computations for the period of 4th-10th November, 2019 (week-32) for Haryana. The DSA account for week-32 was revised, accordingly. Subsequently, in the 184th OCC meeting, committee approved the proposal of waiving of interest charges for Haryana for late payment of DSM charges for the week-32 of FY 2019-20.

Interest on late payment of Deviation Settlement charges for 1st, 2nd, 3rd and 4th quarter of FY 2019-20 for Haryana has been computed, accordingly, and revised interest statement is given at **Annexure**.
