महोदय/ Sir,

Regional Transmission Deviation Account for the billing month of January, 2024 (billing period November, 2024) was issued by NRPC vide letter of even no. dated 29.12.2023 wherein transmission deviation for the DIC-JSW(KW)/ Jaiprakash Power Venture Limited was calculated considering GNA quantum of 880 MW. However, an additional provisional GNA of 165 MW was issued to JSW(KW) by CTU vide its letter dated 29.09.2023 (copy enclosed). In view of this, transmission deviation for the DIC-JSW(KW)/ Jaiprakash Power Venture Limited is revised considering GNA quantum of 1045 MW.

Accordingly, Amendment-I to Regional Transmission Deviation Account for billing month of January, 2024 (billing period November, 2024) is hereby issued for information and necessary action by the concerned.

Sub: Provisional GNA to M/s JSW Hydro Energy Ltd. (Karcham Wangtoo HEP) (165 MW) in line with para no. 76 of CERC order dated 22-09-2023 in Petition No. 11/SM/2023 i.r.o. removal of difficulties.

Dear Sir/Ma'am,

This is with reference to CERC vide order dated 22-09-2023 in the Petition No. 11/SM/2023 i.r.o. Removal of difficulties (First Order) in giving effect to certain provisions of CERC GNA Regulations 2022. The para no. 76 of the above order provides as under:

"76. We observe that an entity which was connected to the grid, covered under Regulation 37.6(1) and injecting power on short term basis should not be bottled up for want of processing time by CTUIL. We are of the considered view that such an entity covered under Regulation 37.6(1) where CTUIL is not able to grant GNA before 1.10.2023, shall furnish the Conn-BG3 @ Rs.2 lakh/MW towards such additional GNA including entities covered under subclause (b) of Regulation 37.6(1). Post such submission of Conn-BG3, CTUIL shall issue provisional GNA to such entity post which such entity shall be eligible to get its power scheduled for the quantum of GNA sought for and for which Conn-BG3 has been furnished, subject to availability of transmission system, by treating such access as deemed T-GNA (for the quantum for which GNA is not made effective) and shall not be required to pay T-GNA charges. In case of entities covered under Regulation 37.6(1)(b), CTUIL shall intimate Conn-BG2 as per Regulation 8.3 of GNA Regulations, after which the Conn-BG3 already submitted by such entity shall be adjusted and Conn-BGs in accordance with Regulation 37.6(1) (b) shall need to be submitted by the entity. CTUIL is directed to process the grant of additional GNA within the maximum timeline of 6 months from the date of submission of Conn-BG3 @Rs.2 lakh/MW by such entity."

In view of the above, entities were required to furnish Conn-BG3 @ Rs.2 Lakh/MW towards additional GNA quantum covered under Regulation 37.6(1) (for which Connectivity has been granted & effective and is not having LTA) including entities covered under subclause (b) of Regulation 37.6(1). Post such submission of Conn-BG3, CTUIL shall issue **provisional GNA** to such entities post which such entity shall be eligible to get its power scheduled for the quantum of GNA sought for and for which Conn-BG3 has been furnished, subject to availability of transmission system, by treating such access as deemed T-GNA (for the quantum for which GNA is not made effective) and shall not be required to pay T-GNA charges.

Accordingly, all such entities were advised to submit the application and Conn-BG3 @ Rs. 2 Lakh/MW for the quantum for which Connectivity has been granted & effective and is not having LTA for enabling CTUIL to issue provisional GNA as per above.

The applicable Conn-BG3 has been received from JSW Hydro Energy Ltd.

In view of the above, provisional GNA of 165 MW is issued to JSW Hydro Energy Ltd. (Karcham Wangtoo HEP) post which M/s JSW Hydro Energy Ltd.(Karcham Wangtoo HEP) shall be eligible to get its power scheduled in line with para 76 of CERC order dated 22-09-2023 in Petition No. 11/SM/2023.
