Minutes of the 28th LGBR Sub-Committee meeting

- 1. 28th LGBR Sub-Committee meeting was held on 06.12.2022 through Video Conference.
- 2. Member Secretary, NRPC extended a warm welcome to all participants in the meeting. He informed that this meeting is being conducted to review the planned maintenance schedule of generating units in April'23 and other peak demand months of northern region.
- 3. NRPC representative informed that 27th LGBR Sub-Committee meeting was held on 27.09.2022 and minutes of the meeting were issued on 29.09.2022.
- 4. It was mentioned that based on the deliberation held in the ministry during meeting held on Outage planning for next one year dated 22.11.2022, Ministry of Power has desired that planned outages in the month of April'23 should be minimum possible so as to have adequate thermal capacity available to meet non-solar peak demand.
- 5. Further NRPC representative apprised LGBR sub-committee that Chairperson, CEA during the meeting held on 02.12.2022 for finalization of outage planning for the year 2023-24, asked RPC's that the outages planned in the month of April-23 may please be shifted completely to the lean months periods due to high forecast of demand in this month in the country.
- 6. In this regard, LGBR sub-committee deliberated upon the list of thermal unit outages in NR for April'23 and other peak months of NR that were provisionally approved in the 27th LGBR Sub-Committee meeting and based on the discussion held in the meeting. the subsequent revised schedule is as below:
