अगली टी.सी.सी (43 वीं) और एन.आर.पी.सी. (46 वीं) बैठकें संभावित रूप से पी.जी.सी.आई.एल. द्वारा नियोजित की जा रही हैं। इस संबंध में विस्तार नियत समय में सूचित किया जाएगा।

तत्पश्चात क्रमशः 11 और 12 दिसंबर, 19 को आर.वी.पी.एन. द्वारा जैसलमेर में 44 वीं टी.सी.सी और 47 वीं एन.आर.पी.सी. बैठकें प्रस्तावित हैं। इस अवधि के दौरान जैसलमेर में पीक टूरिस्ट सीजन को देखते हुए, होटल में कमरों की बुकिंग पहले से से की जानी है, और इसलिए आर.वी.पी.एन. ने अपने 23.07.2019 दिनांकित पत्र सं. RVPN / CE (LD) /F/2019-20/D.379 दिनांक 23.07.2019 (एक प्रति संलग्न) ने यात्रा कार्यक्रम के लिए अनुरोध किया है। सदस्यों से अनुरोध है कि वे निर्धारित प्रारूप में आवश्यक विवरण भेजें।

The next TCC (43<sup>rd</sup>) & NRPC (46<sup>th</sup>) meetings are tentatively being planned by PGCIL. The detail in this regard shall be intimated in due course.

Thereafter 44<sup>th</sup> TCC and 47<sup>th</sup> NRPC meetings are proposed at Jaisalmer by RVPN on 11<sup>th</sup> and 12<sup>th</sup> December, 19 respectively. In view of peak tourist season at Jaisalmer during this period, booking of hotel rooms is to be done well in advance, and therefore RVPN vide its letter no. RVPN/CE(LD)/F/2019-20/D.379 dated 23.07.2019 (a copy enclosed) has requested for tentative travel programme. Members are requested to send the required details in the prescribed format.
