#### A.1 Approval of MoM of 52<sup>nd</sup> NRPC meeting

- A.1.1 Minutes of 52<sup>nd</sup> NRPC meeting was issued on 21.04.2022. No comment has been received till the date.
- A.1.2 Members may kindly approve the MoM.

#### A.2 High loading of 400kV Bhinmal-Zerda line

- A.2.1 Matter was deliberated in 51<sup>st</sup> NRPC meeting and it was decided that CTU would take necessary steps after discussion with all stakeholders.
- A.2.2 CTU has intimated that matter was discussed in the 5<sup>th</sup> consultation meeting for evolving Transmission Schemes in NR. Minutes of the meeting is enclosed as Annexure-I.

#### A.2.3 Members may kindly discuss.

#### A.3 Replacement of reactors of Singrauli Transmission System

- A.3.1 Matter was deliberated in 51<sup>st</sup> NRPC meeting and it was decided that CTU would take necessary steps after discussion with all stakeholders.
- A.3.2 In the meeting, CTU representative affirmed that they will analyse the requirement of proposed reactors and and submit its recommendation in next NRPC meeting. CTU has intimated that matter was discussed in the 5<sup>th</sup> consultation meeting for evolving Transmission Schemes in NR. Minutes of the meeting is enclosed as Annexure-I.

#### A.4 Default in release of outstanding dues by THDCIL's Beneficiary

A.7.1 THDC India Ltd has highlighted that as on 12.04.2022, an overdue amount including LPS of approx. Rs.320.21Cr. is due for payment and same has been vigorously pursued with JKPCL (J&K DISCOM) for expeditious payment. Despite vigorous follow up, JKPCL (J&K DISCOM) has still to liquidate its old outstanding

due. The details of the overdue amount on JKPCL (J&K DISCOM), as on 12.04.2022, is as under:

- A.7.2 Long pending dues are to be liquidated by the JKPCL (J&K DISCOM). The amount is quite substantial and crucial. Due to scarce availability of funds with us, we are compelled to avail borrowings to meet our day to day working capital needs, for servicing our long-term debts and adversely affecting our ongoing works. Thus, immediate payment is very much crucial for sustenance of THDCIL.
- A.7.3 JKPCL (J&K DISCOM) is requested to liquidate its above outstanding dues immediately.

#### A.5 Request for opening of Letter of Credit

A.5.1 J&K has not opened the Letter of Credit (LC) amounting to Rs14.45 Cr for Financial Year 2022-23 till date.

#### A.5.2 It is requested to J&K to open the LC of requisite amount immediately.

#### A.6 Operation and Maintenance of Lifts in NRPC Sectt through GeM

- A.6.1 Presently, there are two lifts at NRPC office which are of OTIS and UT make. The AMCs for both the lifts were expired, accordingly a separate tender for AMC of lifts (OTIS and UT make) were floated on GeM on 14.03.2022. In both tenders, only one bid was received and found technically eligible for price bid opening.
- A.6.2 After opening of price bid in both tenders, the Tender Evaluation Committee has found that following rates have been quoted by the sole bidder viz., M/s ACME Elevators:
  - AMC of OTIS lift: Rs.1,09,999.92/-
  - AMC of UT lift: Rs.1,09,999.92/-
- A.6.3 Further, price reasonability aspect was examined and following is observed:
  - Last contracted value for AMC of OTIS lift in NRPC during 2019-20 was Rs.1,26,838/- (excluding taxes).
  - Last contracted value for 2 yr. maintenance contract of UT lift in NRPC during 2019-21 was Rs.2,37,043/- (Rs.118521.50/- for one yr). inclusive of taxes.
  - Hence, prices offered by M/s ACME Elevators in the instant tender are less than the past contracted cost and found to be reasonable.
  - As per rule no. 173(xxi) of GFR 2017, the current tender has to be treated as Single Tender Contract. As per rule no. 173(xix)(a) of GFR 2017, all bids can

be rejected when effective competition is lacking. However, rule no. 173(xx) of GFR, states as under:

• Lack of competition in rule 173(xix) shall not be determined solely on the basis of the number of Bidders. Even when only one Bid is submitted, the process may be considered valid provided following conditions are satisfied:

a. the procurement was satisfactorily advertised and sufficient time was given for submission of bids.

- b. the qualification criteria were not unduly restrictive; and
- c. prices are reasonable in comparison to market values
- A.6.4 In the instant tender, adequate advertisement and time was ensured by conducting tender on GeM portal; basic eligibility conditions were stipulated and were not restrictive; tender has been conducted twice; and offered prices are reasonable as compared to last contracted cost. Thus, in view of rule no. 173(xx) of GFR, it is proposed that offer of M/s ACME Elevators in above said two tenders may be accepted. The instant tenders are resulting to Single Tender Contract, and requires concurrence of NRPC forum for awarding both GeM tenders to M/s ACME Elevators at cost of Rs.1,09,999.92/- (inclusive of all taxes).

#### A.6.5 Members may kindly deliberate and approve.

#### A.7 Requirement of Funds for Allocation to CPWD

A.7.1 CPWD was awarded different types of work in the FY 2019-20. The payments for majority of the works have been released to CPWD except following works:

- A.7.2 This payment is pending due to budget restrictions by PAO. CEA has been regularly followed up for the payment to CPWD such as below:
  - NRPC letter no. NRPC/Accts/509/6808-10 dated 23.07.2021 addressed to CEA., wherein it was requested to review the head-wise permissible expenditure limits for NRPC. In the said letter, it was also requested to allocate Rs.14 Lakh to CPWD under Minor Works (MW) head, for the Annual Repair & Maintenance works carried out at NRPC Office & Residential Building.
  - Further, vide letter No. NRPC letter no. NRPC/SER/310/1/2021 dated 27.08.2021 addressed to CEA, it was again requested that approval of competent authority may kindly be sought for keeping the curtailed amount of

Rs.6,90,971/- under MW head, at the disposal of CPWD so that payment of at least half of the due can be made to the contractors.

- 3. In continuation to the above letters, it was again requested by NRPC vide letter no. NRPC/SER/310/1/2021/10730-10731 dated 18.11.2021 addressed to CEA that approval of competent authority may kindly be obtained for keeping adequate amount at the disposal of CPWD so that due amount can be paid to CPWD contractor(s).
- Further, vide letter No. NRPC/SER/310/1/2021/11467 dated 15.12.2021, NRPC requested that approval of competent authority may kindly be obtained for keeping amount of INR 12.68 Lakhs at the disposal of CPWD so that the due amount can be paid to CPWD contractor(s).
- CEA vide above letter had asked NRPC to seek relaxation from PAO, CEA/MoP before proposal for placement of funds Rs12,68,000/- is considered and it also mentioned that NRPC had been permitted to spend Rs. 6,90,971 /from MW head in FY 2021-22.
- In response, NRPC Vide Letter No. NRPC/SER/310/1/2021/12077-12079 dated 31.12.2021 addressed to CEA, requested that approval of competent authority may kindly be obtained for keeping amount of Rs. 6,90,971/- from Minor Work head at the disposal of CPWD on priority.
- 7. Vide Order No. 12 of CEA, competent authority accorded approval for the placement of funds to the tune of Rs. 6,90,971/- (Rupees Six Lakhs Ninety Thousand Nine Hundred & Seventy-One only) at the disposal of CPWD, for Annual Repair and Maintenance of NRPC office and Residential building (SH: Civil & Electrical works). However, due to the budget ceiling limit imposed for the 4<sup>th</sup> quarter of the financial year 2021-22, only Rs. 80,000/- were available against Rs. 12.68 Lakh, under Minor Works head.
- NRPC vide letter no. NRPC/SER/310/1/2022/1557 dated 10.02.2022 requested CEA for obtaining approval of Competent authority for keeping amount of Rs. 80,000/- at the disposal of CPWD, so that at least some part of the due amount can be paid to CPWD contractor(s).
- Further, vide letter no. NRPC/SER/310/1/2022/1874 dated 17.02.2022 CEA was requested that NRPC being a self-financing organization, whose entire budget allotted by CEA is reimbursed to exchequer on quarterly basis, therefore, payment of Rs.12.68 Lakh may be released from NRPC Fund to CPWD, considering it as an extraordinary case.
- 10. Further, in view of the revised estimate for 2021-22 received vide CEA letter No. 1/1/2021-Bud.(CEA)/56-103 dated 28.02.2022, vide which provision of Rs 17.63 Lakh was available under Minor Works head, NRPC vide letter no. NRPC/SER/310/1/2022/2651 dated 09.03.2022 once again requested CEA for obtaining approval of competent authority for keeping amount of Rs.12.68 Lakh at the disposal of CPWD on priority.

- 11. Further, vide Re-appropriation order No. 4/1/21-Bud (CEA)/229-235 dated 24.03.2022 of CEA (Reference no. 18), amount of Rs. 12.68 Lakh was allocated under Minor Works head of NRPC for FY-2021-22 after re-appropriation and NRPC requested vide mail dated 25.03.2022 to issue authorization letter in favour of CPWD. However, no payment has been released till now.
- A.7.3 CPWD also vide various letters had intimated that the amount has not been received in CPWD account and they are not able to make payments to contractors. During 2020-21, CPWD had even requested to release at least Rs.9 Lakh for one work, so as to pacify the mental agony faced by the contractors, who were pressing hard to release the payment as they had further borrowed money from the market, which was required to be settled.
- A.7.4 CPWD again and again requested to clear long outstanding dues to resolve issue amicably and avoid any unnecessary litigation in future.
- A.7.5 In view of the repeated requests of CPWD and inability to release funds from allocated budget, it is proposed that funds may be released from NRPC Fund on priority basis to avoid any litigation. Copy of correspondences are enclosed as Annexure-II.

#### A.7.6 Members may kindly deliberate and approve.

#### A.8 Proposed services contract in NRPC sect.

- A.8.1 Following services are proposed to be procured from GeM under the Manpower Outsourcing Services - Minimum wage category:
  - (i) Data Entry Operator (2 nos.) 5 days per week
  - (ii) Sweeper (4 no.) 6 days per week
  - (iii) Watch and Ward (3 no.) 7 days per week
  - (iv) Mali (1 no.) 6 days per week
  - (v) Plumber (1 no.) 6 days per week
  - (vi) Electrician (1 no.) 6 days per week
  - (vii) Accounts Officer (1 no.) 5 days per week
- A.8.2 Estimated cost for the outsourced services has been worked out as Rs. 43.39 Lakh per annum. Wages of above mentioned manpower except for Accounts Officer is as per Minimum wages Act of Ministry of Labour & Employment of Govt. of India. Salary of Accounts Officer is taken as per the decision taken in 42<sup>nd</sup> NRPC meeting.
- A.8.3 The Internal Audit report for FY 2019-20 has made an observation that Human Resource Outsourcing contract and Security Manpower service needs approval of IFD, MoP. Accordingly, post-facto approval was obtained for FY 2019-20 vide letter dated 28<sup>th</sup> December, 2021. Further, proposals were submitted for post-facto approval of outsourcing manpower hired in FY 2020-21 in December 2021; however, approval is yet to be received.

- A.8.4 Further, on 15<sup>th</sup> April 2022, proposal has also been submitted for approval of IFD, MoP for hiring manpower in FY 2022–23, however any response is yet to be received.
- A.8.5 In this regards, it is to be highlighted that works at NRPC are being significantly affected due to non-availability of supporting staff. Hence, it is proposed that manpower outsourcing works to be hired at minimum wages may be approved by NRPC.
- A.8.6 Members may kindly deliberate and approve.

# Subject: 5<sup>th</sup> Consultation Meeting for Evolving Transmission Schemes in Northern Region-Minutes of Meeting

The application was discussed in 5<sup>th</sup> Consultation Meeting for Evolving Transmission Schemes in Western Region (CMETS-WR) held on 30.03.2022 (Forenoon). In the meeting it was deliberated that System studies have been carried out for solar max scenario with high RE(Solar) generation in Rajasthan, low demand in Northern region, high demand in Gujarat and less self generation of Gujarat due to issues of imported coal based conventional generations in Gujarat (mainly CGPL & Mundra UMPP). Power flow of 1000MW on Mundra-Mahendargarh bipole in reverse direction (NR to WR) has been considered. Existing / under implementation transmission system under execution expected to be commissioned within next 6 calendar months has been considered.

From the studies, it was observed that the limiting constraint is observed to be Zerda-Bhinmal 400kV S/c line. Power flow on Zerda-Bhinmal 400kV S/c line is about 900MW under N-1 of Zerda-Kankroli 400kV S/c line (874MVA is thermal limit). Further, 400kV Bikaner (RVPN)- Bikaner (PG) 400kV S/c line (quad) is also observed to be critically loaded.

In the CMETS-WR meeting, it was noted that as per CERC Connectivity Regulations/Detailed Procedure, Medium-term Open Access can be granted if the resultant power flow can be accommodated in the existing transmission system or the transmission system under execution expected to be commissioned within next 6 calendar months. In view of the above transmission constraints, after further deliberations, it was decided that the MTOA sought by M/s ASHPL for transfer of 300MW power to MSEDCL, Maharashtra (WR) from their 300MW solar power plant in Bhadla-II, Rajasthan cannot be granted and the application is agreed to be closed. Same is agreed in this (CMETS-NR) meeting also.

#### B. ISTS Expansion in Northern Region

#### 1. Scheme to relieve high loading of 400 kV Bhinmal-Zerda line

CTU informed that the Joint Study Meetings on Transmission Planning for Northern Region & Western Region were held on 21.03.2022, 28.03.2022 & 29.03.2022 over VC amongst CEA, CTU, POSOCO, NRPC, WR and NR constituents to deliberate on requirement of NR-WR Inter-regional corridor to relieve overloading of Bhinmal-Zerda line under various operating conditions.

In the joint study meeting, following scheme was proposed as per the immediate requirement (short term) as well as requirement in 2024-25 (medium term) time frame to relieve high loadings on NR-WR inter regional lines:

#### <u>Phase-I</u>(For Short term)

- Bypassing of 400 kV Kankroli Bhinmal-Zerda lines at Bhinmal to form 400 kV Kankroli Zerda (direct) line #
- Reconductoring of 400 kV Jodhpur(Surpura)(RVPN) Kankroli S/c line with twin HTLS conductor\*-188 km

#### <u>Phase-II</u>(For medium term)

- Establishment of 765/400 kV, 2x1500 MVA Jalore/Bhinmal S/s at a suitable location near Jalore/Bhinmal
- 400 kV Jalore/Bhinmal Bhinmal(PG) D/c line(Twin HTLS)-40 km
- LILO of both circuits of 400kV Fatehgarh-3 PS Jaisalmer-2 (RVPN) line at Jalore/Bhinmal(LILO length 200 km)
- 765kV Fatehgarh-3 PS- Jalore/Bhinmal( D/c line -210 km
- 765kV Jalore/Bhinmal Chittorgarh(PG) D/c line -210 km
- 765kV Chittorgarh(PG) Indore(PG) D/c line- 290 km
- Associated reactive compensation

*# with necessary arrangement for bypassing Kankroli- Zerda line at Bhinmal with suitable switching equipment inside the Bhinmal substation. \* with minimum capacity of 2100 MVA/ckt at nominal voltage* 



#### Proposed NR-WR IR strengthening scheme

After detailed deliberations in the joint study meetings, it was decided that Ph-1 (short term) scheme may be implemented as inter regional system strengthening scheme (ISTS). Same was also agreed in this meeting.

It wad further mentioned that 400kV line bay equipment each at Kankroli and Jodhpur (Surpura)(RVPN) S/s for 400 kV Jodhpur (Surpura)(RVPN) – Kankroli S/c (twin moose) line are having 2000 A current rating which needs to be upgraded with 3150 A rating in above scheme.

The scope of work of above North-West Inter-regional system strengthening scheme shall include following elements:

- Bypassing of 400 kV Kankroli Bhinmal-Zerda line at Bhinmal to form 400 kV Kankroli Zerda (direct) line #
- Reconductoring of 400 kV Jodhpur (Surpura)(RVPN) Kankroli S/c (twin moose) line with twin HTLS conductor\*-188 km

# with necessary arrangement for bypassing Kankroli- Zerda line at Bhinmal with suitable switching equipment inside the Bhinmal substation. \* with minimum capacity of 2100 MVA/ckt at nominal voltage; Upgradation of existing 400kV bay equipments each at Jodhpur (Surpura)(RVPN) and Kankroli S/s(3150 A)

Phase-II medium term scheme was also agreed in principally. However, same shall be reviewed during comprehensive analysis for 75 GW RE Potential in Rajasthan as part of 500 GW RE plan. In case, with additional LTA (about 3 GW) beyond 23 GW in Rajasthan, if requirement of additional corridor from NR to WR arises, Ph-2 medium term scheme can be reviewed earlier also.

#### 2. Sharing of proportionate cost for multi circuit tower used for Varanasi (PG) - Jaunpur 765 kV D/c line

It was deliberated that POWERGRID vide their letter dated 21/02/2022 has informed that following transmission scheme is under Construction at presesnt:

- > Varanasi (PG) Jaunpur (UPPTCL) 400 kV D/c line (being implemented by UPPTCL)
- Construction of 2 Nos. of 400 kV bays at Varanasi (PG) S/s (being implemented by Power Grid)

POWERGRID also informed that UPPTCL had initially planned to terminate their Varanasi-Jaunpur 400 kV D/c line on D/c tower, however, this arrangement was effecting the ROW for other future bays. Accordingly, POWERGRID informed UPPTCL to implement the said 400 kV D/c line on multi-circuit tower near to the Gantry, for which UPPTCL vide their letter dated 17/12/2021 insisted for sharing the additional cost that would be incurred due to change in tower configuration and sought following confirmation:

- a) In future, if the said transmission system shall be used by any third party, the proportionate cost shall be realized from them by Power Grid and transferred to UPPTCL.
- b) In future, if the said transmission system shall be used by Power Grid, the proportionate cost shall be remitted to UPPTCL.

In view of the above, it was agreed that future user (TSP) utilizing the UPPTCL multi circuit tower, should share the proportionate cost. In case POWERGRID utilises the above multi circuit tower for its future transmission scheme under RTM, cost shall be shared by POWERGRID. Further, in case transmission scheme is implemented under TBCB, requirement of cost sharing shall be mentioned in the RfP document of the BPC, for which UPPTCL shall have to share the cost estimate & its basis for sharing by the TSP who wins the bid, at the time of finalisation of such scheme in CMETS/NRPC meetings.

#### 3. Replacement of reactors of Singrauli Transmission System

It was deliberated that in the 51<sup>th</sup> NRPC meeting held on 25.02.22, POWERGRID agenda for replacement of 420kV 50MVAR Agra Line Reactor at Kanpur substation and 420kV 50MVAR Lucknow Line Reactor at Bareilly substation installed under Singrauli Transmission System was discussed. In the meeting, it was delibrated that the conditions of these reactors are not good as they have already completed 40 years and 36 years in service respectively. Accordigengly, petition was filed in CERC to replace these reactors under Add Cap 2019-2024. Hon'ble CERC has directed POWERGRID to approach RPC for its approval. In the NRPC meeting, it was decided that CTU shall analyse the requirement of above line reactors.

#### > 420kV 50 MVAR Agra L/R at Kanpur, Year of manufacturing: 1981

It is to mention that 400kV Agra(PG) – Kanpur(PG) S/c line (Twin moose) is 240km long line and has 50MVAr line reactors at both ends. As informed by POWERGRID, 420kV 50MVAR Agra Line Reactor at Kanpur has completed 40 years of service whereas line reactor at other end is healthy. It was also informed by POWERGRID that during Condition based Maintenance of above Reactor, increasing trend of Furan content, moisture and DGA was observed. M/s CPRI (Third party) was approached to analyse the test results and to assess the condition of the equipment. CPRI has recommended for replacement of the said reactor. As already mentioned, the said reactor has completed its useful life and chances of failure of the reactor is very high which may lead to forced outage of line due to high voltage.

CTU has carried out the studies and it is observed that total voltage rise is about 15 kV (without 50 MVAR line reactor at Kanpur end) which shall be reduced to 5kV with the 50 MVAR line reactor at Kanpur end, while charging from Agra end. Considering long length

of above line and study results, it was agreed to install/replace 50MVAr line reactor at Kanpur end on 400kV Agra(PG) – Kanpur(PG) S/c line.

#### > 420kV 50 MVAR Lucknow L/R at Bareilly, Year of manufacturing: 1985

It is mentioned that 400kV Bareilly(PG) – Lucknow(UP) S/c line (Twin moose) is 279km long line and has 50MVAr line reactors at both ends. The 420kV 50MVAR Lucknow Line Reactor at Bareilly has competed 36 years of service. As informed by POWRGRID, during Condition Based Maintenance of above Reactor, increasing trend of Furan content, Low core IR value and DGA has been observed. M/s CPRI (Third party) was approached to analyse the test results and to assess the condition of the equipment. CPRI has recommended replacement of the said reactor. As already mentioned, the said reactor has completed its useful life and chances of failure of the reactor is very high which may lead to forced outage of line due to high voltage.

The studies has been carried out and it was observed that total voltage rise is about 22kV (without 50 MVAR line reactor at Bareilly end) which shall be reduced to 9kV with 50 MVAR line reactor, while charging from Lucknow end. POSOCO enquired wheather higher rating reactor can be considered in place of 50 Mvar Line Reactor, as the line length is long. CTU informed that if 80MVAR line reactor at Bareilly end is considered, total rise shall reduce to 2kV. POSOCO suggested that in view of prevailing high voltage scenario in Northern region as well as less voltage rise during charging, 80MVAr line reactor at Bareilly end may be considered. Accordingly, it was agreed to install 80MVAr line reactor at Bareilly end on above line.

In pursuance of this office letter dated 13.07.2021 on the above subject, PAO (CEA) has revised expenditure/ceiling figures in respect of NRPC for financial year 2021-22 (copy enclosed).

Under the OE head of revised budget ceiling, expenditure of Rs.1,22,97,858/- is considered for FY 2019-20 and the corresponding permissible expenditure limit on OE head for current FY may work out Rs. 98,38,286/- after the curtailment of 20%. However, there appears to be typographical error in the revised budget ceiling for OE head as ceiling is mentioned as Rs. 90,38,286/-. PAO (CEA) is requested for suitable modification under the OE head.

Under the RRT head, expenditure of Rs.3,11,648/- on property tax in 2019-20 has been curtailed by 20% and fixed at Rs. 2,49,318/- for current FY. It is informed that Rs. 3,11,648/- is the estimated property tax amount, and any reduction may lead to deposit of less property tax and fine/penalty thereon by SDMC. Moreover, levy of penalty is subjected to audit objections. Considering the expenditure under RRT head as statutory requirement, PAO(CEA) is requested not to curtail expenditure under the RRT head.

In Minor Works, Rs 6,90,971/- has been allotted. It is informed that Rs.14 Lakh was due for payment to CPWD in the last FY and the amount could not be paid due to budget constraint. With the curtailed amount in current FY, payment of half of the due would get deferred to FY 2022-23. CPWD have been raising repeated concerns on pending due as they are not able to make payments to contractors since last FY. Looking into the difficult situation, allocation of Rs.14 Lakh under OC head may be considered.

In view of the above, head-wise permissible expenditure limits for NRPC may kindly be reviewed and suitable action may be taken.

He is in mental agony due to continous reminders from the market. He has again requested vide his letter dated Nil (copy enclosed) to release his payment with compounding interest of @7% of annually as per GCC clause 9 with 18% interest and stated for legal action.

Hence, keeping in view of the above urgency & requirements, it is once again requested to release at least Rs. 9.00 Lakhs in r/o above mentioned work to clear the long pending liabilities, so that the issue may be resolved amicably and to avoid unnecessary litigation in future.
