**विषय : प्रचालन समन्वय उप समिति की 161वीं बैठक ।**

**Subject: 161<sup>st</sup> meeting of Operation Coordination Sub-Committee (OCC).**

The 161<sup>st</sup> OCC meeting of NRPC is scheduled to be held in two sessions on 15<sup>th</sup> July, 2019 and 16<sup>th</sup> July 2019 respectively. Meeting session on 15<sup>th</sup> July, 2019 will start at 14:00 hrs in which outage program of generating units and transmission lines proposed by the generating companies and transmission licensees respectively for the month of August, 2019 will be approved. This meeting session will be conducted through Video Conferencing. Utility which are not connected to NRPC Secretariat through video conferencing may participate in this meeting session from the nearest SLDC.

It is requested that outage program of transmission lines and generating units shall be uploaded on Transmission system Operation Planning (TSOP) application within the prescribed date. The outage request received through TSOP only will be considered by the OCC.
