विषय: प्रचालन समन्वय उप समिति की 240^{वीं} बैठक की सूचना।

उ.क्षे.वि.स. की प्रचालन समन्वय उप-समिति की **240^{वीं}** बैठक का आयोजन **13.02.2026** एवं **16.02.2026** को किया जाएगा। **मार्च 2026** माह के लिए उत्पादन कंपनियों व पारेषण लाइसेंसधारियों द्वारा प्रस्तावित आउटेज कार्यक्रम पर चर्चा दिनांक **13.02.2026** को **14:00** बजे विडियो कॉन्फ्रेंसिंग के माध्यम से की जाएगी। तत्पश्चात दिनांक **16.02.2026 (10:30 बजे से)** को प्रचालन संबंधित अन्य कार्यसूची मुद्दों पर चर्चा की जाएगी।

The **240th** OCC meeting of NRPC is scheduled to be held on **13.02.2026** and **16.02.2026** through Video Conferencing. Meeting session on **13.02.2026** will start at **14:00 hrs.** in which outage program of generating units and transmission lines proposed by the generating companies and transmission licensees respectively for the month of **March 2026** will be discussed. Other operation related agenda items will be discussed subsequently on **16.02.2026 (10:30 hrs. onwards).**

It is requested that outage program of transmission lines and generating units may kindly be uploaded on the online portal, available on NRPC website, within the prescribed date. The outage request received through online application only will be considered by the OCC.
