Keeping in view of the surrendered share of Delhi (76 MW) and Haryana (32 MW) from Meja Thermal Power Station Stage-I (2x660) and the willingness of Uttar Pradesh Power Corporation Limited (UPPCL) to avail the surrendered power and concurrence of Meja Urja Nigam Private Ltd (MUNPL) for re-allocation, it has been decided to re-allocate surrendered share of total 108 MW from Meja Thermal Power Station Stage-I (2x660) to Uttar Pradesh.

3. The actual energy generated from the project will be distributed proportionately on the basis of allocation after taking into account the auxiliary consumption.

4. The above allocation will further be subject to the Power Purchase Agreements (PPAs) entered into by NTPC Limited with State Power Utilities/ Union Territory and will further be subject to the beneficiaries ensuring compliance with the financial and commercial terms (including coverage for Letter of Credit) of the PPA signed with NTPC Ltd., the tariff notification and any other directives/ guidelines issued by the Government of India /Central Electricity Regulatory Commission from time to time.

5. In case of failure of the beneficiaries adhering to the condition mentioned above. NTPC Ltd. may shut off or restrict power supply from the power station and also reallocate the power in case beneficiaries default in payment or where they have not opened LCs of an adequate amount in favour of NTPC Ltd. NTPC Ltd. would inform Member Secretary of the Concerned Regional Power Committee of the revised allocation of power in respect of the defaulting beneficiaries. Member 'Secretary of the concerned Regional Power Committee would reallocate the surplus power to the other beneficiaries based on grid security and power situation.

This issues with the approval of the Hon'ble Minster of Power.

Subject: Allocation of unallocated power from Central Generating Stations- regarding.

Ministry of Power (MoP) issues orders for allocation of power from the Central Generating Stations (CGSs) to the beneficiary States/UTs. The allocation consists of firm power generally amounting to 85% of the installed capacity of the CGSs and 15% as unallocated power. Unallocated power of various CGSs in a region is generally pooled to form a regional unallocated power pool. The allocation of power from this unallocated pool is reviewed from time to time by the MoP and it is allocated / reallocated taking into consideration various factors.

2. It has, however, come to the notice that unallocated power of some new CGSs has not been added to the existing unallocated regional pool and it has been distributed to the beneficiaries of the new CGS in proportion to their firm shares in view of the following provision in CERC (Terms & Conditions of Tariff Regulations), 2014:

"In the absence of any specific allocation of unallocated power by the Central Government, the unallocated power shall be added to the allocated shares in the same proportion as the allocated shares."

3. It is hereby clarified that in the absence of any specific allocation out of unallocated quota of a new CGS Unit/ Power Station by the MoP, its unallocated quota will be added to the existing unallocated power pool of the concerned region and distributed among the existing beneficiaries of the pool in the proportion approved by MoP.

4. Project Divisions of Ministry of Power i.e. Thermal and Hydro Divisions are requested to specifically mention in the allocation orders issued by them that the unallocated power on declaration of commercial operation of any unit/station will be added in the existing regional power pool and allocated to the states/UTs as per existing proportion of allocation of unallocated power as approved by the Ministry of Power from time to time.

5. CERC is advised to amend the relevant provision in CERC Tariff Regulations 2014 (mentioned in Para '2' above) as under:-

"In the absence of any specific allocation of unallocated power by the Central Government, the unallocated power of the power station shall be added to the concerned regional unallocated power pool and allocated to the beneficiaries of that pool in accordance with the orders already issued by Central Government."

6. CEA is advised to revise the distribution of the unallocated power in the cases where it was done to beneficiaries of a Central Generating Station in proportion to their firm allocation from that station. This unallocated power would be added in the existing regional pool and allocated to the States / UTs as per existing proportion of allocation of unallocated power already approved by the Ministry of Power.
