Subject: Revision in allocation of power from Central Generating Stations in Northern Region Revision No - 04/2019-20

- 1. MoP vide letter no. 3/6/2018-0M dated 21.01.2019 had directed to reallocate 30 MW power surrendered by Punjab in Unchahar-I TPP to Arunachal Pradesh for a period of three months from 01.02.2019 to 30.04.2019. NRPC had subsequently issued allocation order no. 12/2018-19 on 28.01.2019 for the implementation of the same.
- 2. MoP vide letter no. 3/6/2019-0M dated 29.04.2019 had directed to extend this allocation of 30 MW power from Unchahar-I TPP to Arunachal Pradesh from 01.05.2019 to 07.05.2019.
- 3. In partial modification to above letter, MoP vide letter no. 3/6/2019-0M dated 04.05.2019 directed to allocate 30 MW power from Unchahar-I TPP back to Punjab w.e.f. 00:00 hrs of 05.05.2019. However, the letter from MoP was received in NRPC on 06.05.2019. MoP was informed that the allocation from Unchahar-I TPP can only be implemented w.e.f. 00:00 hrs of 07.05.2019 to which they have agreed.
