Grid Management Division, Central Electricity Authority vide email dated 17.03.2023 (copy enclosed at Annexure-I) has forwarded Ministry of Power letter (MoP) dated 17.03.2023 (copy enclosed at Annexure-II) whereby existing allocation of 179 MW Power from NTPC's Dadri-I TPP is extended upto 31.03.2023. The same was, earlier, allocated to Rajasthan upto 2400 hrs of 25.03.2023 vide NRPC allocation order revision no. Alloc06/2021-22 dated 25.03.2022, GM Division, CEA it its email has requested to implement MoP order dated 17.03.2023.

- Accordingly, NRLDC, GRID-India is requested to implement the existing allocations from Dadri-TPP upto 2400 hrs of 31.03.2023.

- 2. In case some unit(s) in the above mentioned plant is/are under shutdown at present, the share equivalent to that unit shall not be considered as reallocated to Rajasthan as the State needs power to meet its urgent requirement,
