Subject: Compensation for Degradation of Heat Rate and Auxiliary Consumption due to Part Load Operation for billing period of August, 2025 along with the Revised Compensation statement for April-July, 2025.

महोदय/ महोदया,

केंद्रीय विद्युत विनियामक आयोग के टैरिफ की शर्तें एवं नियमावली, 2024 के विनियम 70(जी)(10), के तहत दिनांक 4 फरवरी 2025 के संशोधन द्वारा लागू एवं केंद्रीय विद्युत विनियामक आयोग द्वारा आदेश संख्या L-1/268/2022/CERC, दिनांक 14 जुलाई 2025 के माध्यम से अनुमोदित विस्तृत प्रक्रिया के तहत जारी प्रावधानों के अनुसार, आंशिक भार परिचालन के कारण क्षेत्रीय इकाई तापीय उत्पादन केंद्रों के लिए हीट रेट एवं सहायक खपत में गिरावट हेतु, अगस्त 2025 की बिलिंग अवधि के लिए तथा अप्रैल, 2025 से जुलाई, 2025 की बिलिंग अवधियों हेतु संशोधित प्रतिपूर्ति जारी की जाती है (प्रति [NRPC website](http://www.nrpc.gov.in) पर भी उपलब्ध है)। यह प्रतिपूर्ति ISGS द्वारा प्रस्तुत आवश्यक डेटा (आउटपुट विवरण एवं ईंधन संबंधी डेटा) के आधार पर निर्गत की गई है।

इसके अतिरिक्त, 'SCED और SCUC के कारण आंशिक भार परिचालन के लिए प्रतिपूर्ति विवरण' CERC (भारतीय विद्युत ग्रिड कोड) विनियम, 2023, और सुरक्षा बाधित यूनिट कमिटमेंट (SCUC), यूनिट शटडाउन (USD), तथा क्षेत्रीय स्तर पर सुरक्षा बाधित आर्थिक डिस्पैच (SCED) के लिए विस्तृत प्रक्रिया के अनुसार तैयार किया गया है, जो CERC आदेश संख्या L-1/265/2022/CERC दिनांक 16 अप्रैल 2024 द्वारा जारी किया गया है।

सम्बंधित सभी क्षेत्रीय इकाइयों से अनुरोध किया जाता है कि यदि इस संबंध में कोई विसंगति या त्रुटि हो, तो इस पत्र के जारी होने की तिथि से दिनों के भीतर सूचित करें। यदि निर्दिष्ट अवधि के भीतर कोई प्रतिक्रिया प्राप्त नहीं होती है, तो खार्तों को सही मानते हुए अंतिम रूप से स्वीकार कर लिया जायेगा।

In accordance with the 'Procedure for mechanism of compensation for degradation of Station Heat Rate, Auxiliary Energy Consumption and Secondary fuel oil consumption due to part-load operation and multiple start/stop of the units' approved by the Central Electricity Regulatory Commission (CERC) vide order no. No. L-1/268/2022/CERC dated 14th July 2025 under provisions of Regulation 70(G)(10) of the Central Electricity Regulatory Commission (Terms and Conditions of Tariff) (First Amendment) Regulations, 2025, the **statement of compensation** for degradation of

heat rate and increase in auxiliary consumption due to **part-load operation** of regional entity thermal generating stations—whose tariffs are determined under Section 62 of the Electricity Act—is hereby **issued** for the billing period upto **August, 2025** along with revised compensation statement for the period from April, 2025 to July, 2025. Statement of compensation is based on the requisite data (including outage details and fuel-related information) submitted by the ISGSs.

Additionally, the '**Statement of Compensation due to Part Load Operation on Account of SCED and SCUC**' has been prepared in line with the CERC (Indian Electricity Grid Code) Regulations, 2023, and the Detailed Procedure for Security Constrained Unit Commitment (SCUC), Unit Shut Down (USD), and Security Constrained Economic Dispatch (SCED) at the regional level, issued vide CERC order no. L-1/265/2022/CERC dated 16th April 2024. A copy of the statements is also available on [NRPC website](#).

All concerned regional entities are requested to communicate any discrepancies or errors, if any, within **15 days** from the date of issuance of this letter. In the absence of any such communication within the stipulated period, the accounts shall be deemed correct and considered final.
