In continuation, it is intimated that in an amendment to Certification of Open Cycle generation from Anta GPP for the months from July' 2021 to Nov'2021 and Auraiya GPP for the months of September 2021 and March 2022 is issued by NRPC in compliance with Regulation 43(2)(b) of Central Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2019 vide NRPC letter dated **02.09.2022** (copy enclosed). Accordingly, differential amount receivable by NTPC Limited on account of revision in certified Open Cycle Generation by Anta GPP and Auraiya GPP due to schedule given under the ancillary services in the RRAS account for the months of July' 2021 to Nov'2021 and March 2022 is given at **Annexure-I**. Further, total amount receivable by NTPC Limited's gas based generating stations on account of Open Cycle Generation due to schedule given under the ancillary services in the RRAS account for the months of April 2021 to March 2022 including the receivable amount under ancillary services in the RRAS account for the months of April 2021 to March 2022, as issued by NRPC vide its letter dated 15.06.2022, is given at **Annexure-II**.




