Amendment to Notification of Transmission charges payable by DICs for Billing Month of November, 2022

1. Central Electricity Regulatory Commission (Sharing of Inter-State Transmission Charges and Losses), Regulations 2020 came into force with effect from 1.11.2020. National Load Despatch Centre (NLDC) as the Implementing Agency under Sharing Regulations 2020 has been entrusted with the responsibility of computation of ISTS transmission charges and losses.
2. Implementing Agency vide its notification dated 25.10.2022 had notified the transmission charges for the DICs for billing month of November, 2022 in line with Sharing Regulations 2020. Subsequent to the notification, it came into notice that inadvertently, transmission charges to be paid by SJVN Ltd. (Naitwar Mori HEP) as per clause 13(7) of the Sharing Regulations, 2020 has been computed for complete month instead of one day as the date of LTA operationalization is 30.09.2022.
3. In view of the above, Implementing Agency has revised transmission charges to be paid by SJVN Ltd. (Naitwar Mori HEP) as per clause 13(7) of the Sharing Regulations, 2020 and hereby notified for the billing month of November'22 mentioned as follows:
