## **Minutes of the meeting held on 15.07.2016 to discuss the modalities regarding scheduling and accounting of BBMB stations.**

To discuss the modalities for scheduling, metering and accounting of BBMB stations, a meeting was convened on 15.07.2016 at NRPC, New Delhi. List of the participant is enclosed in Annexure-I.

2. SE, NRPC welcomed the participants. He stated that as per CERC order in Petition No. 251/GT/2013, BBMB generating units shall commence the scheduling of power under ABT with effect from 01.06.2016. He informed that in compliance to CERC order, based on scheduling and meter data submitted by NRLDC, NRPC Sectt. has to prepare deviation settlement account in accordance with regulation 2.4.5 of CERC (IEGC) Regulations, 2010.
3. He further, stated that to discuss the modalities for scheduling, metering and accounting of BBMB stations, a meeting was held on 27.05.2016 at Chandigarh, wherein officers from NRPC Sectt., NRLDC and BBMB were present. In the meeting metering arrangements and modalities for scheduling and accounting were discussed in detail. However, it was felt that one more meeting would be required with all the stakeholders to finalise the modalities. Accordingly, this meeting was arranged & in the meeting, after detailed deliberations on all the issues, following decisions were taken:
  - a) Scheduling and Accounting will be done for 3 generating stations of BBMB i.e. Bhakra complex, Dehar and Pong.
  - b) NRLDC will schedule the power from BBMB generating stations based on declared capacity given by BBMB as per provisions of IEGC.
  - c) Initially entitlements of beneficiaries of BBMB generating stations will be calculated as per the existing practice. However, BBMB will endeavour for converting the allocation to its beneficiaries on percentage basis in line with the methodology being adopted for ISGS.
  - d) NFL will be considered as a regional entity and NRLDC will ensure the required metering arrangement for metering of NFL drawal.
  - e) While scheduling, entitlement of Rajasthan Fertilizers will be included in total drawal schedule of Rajasthan.
  - f) Various options regarding Declared Capacity, Scheduling, treatment of diversion of water to ASPS, power consumption by Irrigation Wing etc were discussed. However, it was decided that these issues will have to be primarily dealt based on provisions of IEGC and tariff regulations and hence NRLDC and NRPC Sectt. would hold a seprate meeting to finalise these issues.

Meeting ended with vote of thanks to the chair.
