

Minutes of the meeting taken by Member Secretary (NRPC) on 22.06.2016 regarding the methodology for application of Deviation Settlement Mechanism on POWERGRID HVDC stations.

1. The list of participants is enclosed at Annexure-I.
2. Member Secretary, NRPC welcomed participants. He stated that this meeting is being conducted to deliberate on the issues related to application of Deviation Settlement Mechanism on POWERGRID HVDC stations.
3. SE, NRPC stated that as per order issued by Ministry of Power from time to time, power has been allocated from some of the CGSs in Northern Region to POWERGRID HVDC stations namely HVDC Rihand, HVDC Dadri, HVDC Agra, HVDC Balia and HVDC Bhiwadi for meeting auxiliary power requirement. At present deviation charges are not being applied on this power. He further stated that as per Central Electricity Regulatory Commission (Deviation Settlement Mechanism and other related matters) Regulations, Deviation settlement mechanism is applicable on all buyers and sellers. Therefore it should be applicable on POWERGRID HVDC stations also.
4. Representative of NRLDC stated that these POWERGRID HVDC stations are already registered with NRLDC as entities.
5. After detailed deliberations following decision were taken :-
 - a. Deviation charges will be applied from 01.07.2016 for 5 HVDC stations of POWERGRID that is namely HVDC Rihand, HVDC Dadri, HVDC Agra, HVDC Balia and HVDC Bhiwadi, which are allocated power from CGSs of NR.
 - b. The Deviation charges for all these HVDC stations will be calculated separately and will be aggregated to POWERGRID (NR) as pool member for payment / receipt of charges.
