Sub: Multiple lines tripping and generation loss on 30.11.2016 – meeting notice.

Sir,

At 06.02hr on 30.11.2016, there was tripping of all running machines of Anpara A, B, C & D resulting generation loss of 2300MW. This was consequent to tripling of following transmission lines:

- 400kV Singrauli-Anpara
- 400kV Anpara-Mau
- 400kV Anpara-Sarnath 1&2
- 400kV Anpara-Anpara C 1&2
- 400kV Anpara-Anpara D 1&2
- 400 kV Sarnath-Varanasi 1&2
- 400kV Azamgarh-Sarnath
- 400kV Anpara-Obra
- 400kV Anpara-Anpara-D

On Same day, Talwandi Sabo unit- III tripped at 06:48Hrs & resulted into generation loss of 300 MW, and Unit I & II tripped at 07:24 Hrs which lead to further the generation loss of 1000 MW. Following transmission lines had also tripped:

- 400kV T.Sabo Dhuri ckt-I (6:33) & ckt-II (6:24)
- 400kV T.Sabo Muktsar Ckt-I (7.37) & ckt-II (7.24)
- 400kV T.Sabo Nakodar (6:42)
- 400kV T.Sabo Moga (6:48)
- 400kV Makhu-Amritsar ckt-2 (8:56)

The tripping of lines is prima facie due to fog.

In this connection, Member Secretary, NRPC will take a meeting on 05.12.2016 at 11:00 hrs to deliberate the measures to avoid such trippings in ensuing winter season.

You are requested to designate officers concerned with data regarding these incidents such as type of insulators affected, cleaning record if conventional insulators were affected and action planned. Information about progress of insulator replacement/cleaning on all transmission lines should also brought. The issues regarding scheduling and despatch strategy would also be deliberated.
